

Important Conditions of Entry for Participants:

By your choice to attend as a participant you do so unconditionally, at your own risk all additional conditions displayed in the schedule, on the showground and on our website for general rules and accept the following.

1. You are responsible for ensuring horses, dogs and children with you are kept under strict close supervision at all times and children do not climb or play on any items on the farm. This land is not a safe play area. Horses are highly unpredictable and place all at risk. Horses must be strictly walked at the event, except in designated practice areas. You agree to immediately follow instructions from any official, judge, designated steward etc. The Health & Safety at Work Act means you are responsible for the health and safety of yourself and others at our event.
2. You agree not to hold the Event Organisers and the Owners of the land liable for any injury, loss or damage to any person, animal, vehicle or property, however caused.
3. You agree we have the right at our discretion, without liability for any costs or giving a reason or a refund on pre entered events to a) alter the schedule without prior notice, b) refuse any entry and, c) request you immediately leave the event. Persons using foul, argumentative, abusive or ridiculing language or in our opinion inappropriate actions to school or punish their horse, or being a danger to themselves or others, will be asked to leave. Competitors' entry fees will only be refunded on production of a doctor's or vet's certificate.
4. **Horseboxes and trailers must not be mucked out on showground.** Please actively pick up all litter and droppings as the land is used for grazing!
5. **An approved riding hat to current 2020 BRC standard must be worn properly secured at all times whilst mounted.** A body protector to BETA 3 standard, with purple BETA 2009 or Blue 2018 label displayed, must be worn correctly fitted and properly secured for all cross country competitions and xc practices, and is strongly recommended for all jumping competitions, clear rounds and mock hunts. **Air Jackets must be properly secured whilst mounted.**
6. Competitors' objections, of any kind, must be made in writing to the event secretary within 15 minutes of the incident, accompanied by a deposit of £10, refundable only if the objection is upheld.
7. **No person may enter the warm-up area mounted, without adhering to the rules above and having entered the event, paid entry fee and signed an entry form as acceptance of our conditions**

COVID 19 Restrictions

No spectators are permitted without accompanying a horse to this event.

One Groom/ Driver permitted to accompany each horse and rider participating.

No gathering together at ringside, warm up or in horsebox parking, whether mounted or not.

Keep 2m apart at all times from those not in your bubble.

One way system in place.

Hand sanitiser provided. Please use it.

Masks to be worn when attending Secretary's.

Rosettes and Winner sashes to be collected from outside Secretaries.

Gloves to be worn if changing warm-up jumps

All attendees to provide name and contact number to secretary upon arrival, or log-in to NHS Test & Trace or through Our QR Poster (Outside Secretary's on the day).

All Riders to follow Warm Up and Ring Steward Instructions to limit numbers in Warm Up and waiting areas.
